Tea export to U.S.A.

The Minister of Commerce and Industry (Shri Lai Bahadur Shastri): During January-September, 1958, export of Indian tea to the U.S.A. amounted to 17:89 million lbs. valued at Rs. 4:69 crores as compared with 16:81 million lbs. valued at Rs. 4:72 crores during the same period of last year.
