(b) if so, the reaction of Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND DEPARTMENT OF PARLIA-MENTARY AFFAIRS (SHRI P. VEN-KATASUBBAIAH): (a) Yes, Sir.

(b) Smt. J. Dayawanti, mother of War Hero Flt. Lt. Jerry, visited Tilak Marg Police Station and reported that she was not allowed to cross Rajpath on 26-1-1982 to reach the enclosure earmarked for War Widows in Sector No. 10. Although she did not want the matter to be pursued, yet an identification parade of the police personnel deployed on duty in Sector 11, where she was prevented from crossing, was arranged, but Smt. Dayawanti, could not identify police official who had prevented her.

Instructions have been issued to ensure that such incidents do not occur in future.

Amendment to legislation relating to labour engaged in Small Scale Industries

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI DHARMAVIR): (a) and (b) No, Sir.

(c) the workers derive benefits of legislation by way of minimum wages, social security and other welfare

measures independently of the concessions given to the employers which are meant for promotion of investment and employment.
