The Deputy Minister of Defence (Shri Raghuramatah): (a) In terms of Government's Industrial Policy Resolution dated the 6th April 1948 and the 30th April 1956, manufacture of arms and ammunition and allied items of defence equipment is the exclusive responsibility of the public sector However, the existing units manufacturing arms and ammunition for civilian use in the private sector, who have already been granted licences for such manufacture, are allowed to continue, but they are not permitted to expand their activities
