## Class IV Employees

The Minister of State in the Ministry of Home Affairs (Shri Datar): (a) Middle school standard has been prescribed, with effect from the 16th November, 1951, as the minimum educational qualification for direct recruits to the grades of Peon, Jamadar, Daftry and Record Sorter, in the Ministries as well as the Attached and Subordinate Offices of the Government of India Persons who been appointed to these grades after this crucial date and who do possess the prescribed educational qualifications, are not eligible conferment of quasi-permanent status. unless they belong to the excepted categories namely retrenched manent displaced Government servants, persons demobilised from the Army with 3 year's service, etc

- (c) No such proposal is under the consideration of the Government.

## Punjah University Camp College, New Delhi
