## Safety Measurs in Santa Cruz Airport

10409. SHRI M. RAMANNA RAI: Will the Minister of TOUR-ISM AND CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that Government of India are failing to take all the required safety measures in Santa Cruz Airport even after it has acquired the notoriety as one of the dangerous Airports of the World : and
- (b) if so, the reasons therefor ?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI A. P. SHARMA) : (a) Bombay (Santa Cruz) airport is provided with all the required safety measures viz., visual aids, emergency, rescue and fire fighting services as per the stipulated standards of ICAO (International Civil Aviation Organization). The navigational aids, communication and air traffic control facilities that have been provided and are operating at Santa Cruz airport are, more or less, at par with the facilities that have been made available at the airports in other advanced countries. With a view to ensuring the safety of passengers and aircraft, appropriate security

arrangements at Santa Cruz airport have also been made. These coninternational standards. Action is also in hand to further strengthen perimeter protection and regulate entry into the airport by issue of Photo Identification Cards.

Overstaying of officers in D.T.D. and P. (AIR) Organisation dealing with private trade firms

10412. SHRI JAIPAL SINGH KASHYAP: Will the Minister of DEFENCE be pleased to state;

- (a) whether the officers dealing with private trading firms are being rotated in D.T.D. & P (Air) Organisation of Ministry of Defence Production regularly:
- (b) if so, how three permanently seconded Air Force Officers are in Headquarters, D. T. D. & P (Air) Stationed at Delhi for more than 14 years at a stretch;
- (c) is it true that one of the above three officers had completed twenty years and the other 17 years in the same station; and
- (d) the reasons why some officers are allowed to remain at a station for such a long time?

THE MINISTER OF DEFENCE (SHRI R. VENKATARAMAN): (a) to (d). The transfer of officers are made on the basis of job requirement taking into account the qualifications and experience of the available officers and not on the exclusive basis of dealing with trade firms.

Two permanently seconded Air Force Officers are stationed at Delhi for more than 14 years in DTD & P (Air) Headquarters of whom one has completed 17 years in the same station.
