#### Income Tax Raids

10441. DR. A. U. AZMI: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that the Income-Tax authorities raided the houses of some high-ups recently in Bombay;

(b) if so, details of the raids and the incriminatory wealth, jewellery, records recovered, besides other revealing facts;

(c) are Government considering to launch country-wide raids of the type to unearth more such unsocial activities and award exemplary punishments to be deterrent to others; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SAWAI SINGH SISODIA):

(a) and (b). During the last month searches were conducted by the Income-tax Department at Bombay

in the cases of Cine Artistes Shri Rajesh Khanna and Shrimati Dimple Khanna, her father Shri Chunibhai Kapadia and his associates. During these searches, besides incriminating documents, *prima-facie* unaccounted assets of the value of over Rs. 29 lakhs were seized. A bank account was also kept under prohibitory orders.

(c) and (d). Searches are authorised in cases where on the basis of available information, the authority empowered to authorise search is satisfied that such an action is called for.

ओवरड्राफ्टों की बकाया राशि के  
समक्ष राजस्थान सरकार द्वारा  
अदा की गई राशि

10442. श्री विरदा राम फुलवारिया: क्या वित्त मंत्री यह बताने की कृपा करेंगे कि राजस्थान सरकार ने अपने द्वारा पहले किये गये ओवरड्राफ्टों की बकाया राशि के समक्ष कितनी राशि की अदायगी की है?

वित्त मंत्रालय में राज्य मंत्री (श्री सवाई सिंह सिसोदिया): भारतीय रिजर्व बैंक पर राज्य सरकारों के ओवरड्राफ्ट उनकी दैनिक नकद स्थिति को दर्शाते हैं और इनकी मात्रा में दिन-प्रतिदिन अन्तर होता रहता है। राज्य सरकारों का धन-संबंधी लेन-देन एक साथ ही राज्य के कई खजानों/उप-खजानों तथा बैंकों में होता रहता है। ओवरड्राफ्ट तब होते हैं, जब राज्य सरकारों के खाते में वितरण उनकी प्राप्तियों और प्राधिकृत अर्थोपाय सीमाओं से ऊपर बढ़ जाता है। जब भी राज्य सरकार के खाते में प्राप्तियाँ वितरण से अधिक हो जायेंगी तो ओवरड्राफ्ट की राशि कम हो जायेगी।
