Vamendhara Project

282. Shri Nagi Reddy: Shri Ramam:

Will the Minister of Irrigation and Power be pleased to refer to the reply given to Unstarred Question No 60 on the 18th November, 1958 and state

- (a) whether the investigations for the construction of Vamsadhara Project at Gudari have been completed by the Government of Andhra Pradesh;
- (b) if so, whether the report of the same has been received by the Centre,
- (c) the estimated cost of the project, and
- (d) whether the work would start on the project in the year 1959-60?

The Minister of Irrigation and Power (Hafiz Mohammad Ibrahim): (a) Investigations on the suitability of the Gudari site for construction of a dam for the Vamsadhara Project are being conducted by the Central Water and Power Commission and not by the Government of Andhra Pradesh The work of investigations has not been completed as yet

- (b) and (c) The project report will be prepared by the Central Water and Power Commission and the Government of Andhra Pradesh immediately after the completion of investigations
- (d) It is too early to say if the work would start in 1959-60. The actual execution of the project can only start after the project report is finalised and the project is finally approved by the Planning Commission.

- (c) No systematic studies have been made to assess the comparative output per acre in cooperative farms and in farms owned by individuals and no information is available other than that contained in the Publication No 18 entitled "STUDIES IN CO-OPERATIVE FARMING" brought out by the Programme Evaluation Organisation of the Planning Commission.
