Building at Tundla Station

4113. SHRI DAYA RAM SHAKYA : Will the Minister of RAILWAYS be pleased to state :

- whether at Tundla Station (a) Northern Railway, a primary school is running in Railway Building near Hanuman Mandir (Company Bagh) privately without making any payment of the rent of the building to Railways, and
- (b) what would be the charges for that land and building?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMEN-TARY AFFAIRS (SHRI MALLIKAR-JUN): (a) Yes. For the benefit of Railwaymen's children, a school is being run by representatives of Railway staff to impart basic/primary education mainly wards of Railwaymen. The school is being run on no profit no loss, and no rent is so far being recovered.

(b) Normally in such cases only a nominal licence fee of Rs. 100/- per anrum is charged, as the school is for the benefit for Railway staff.
