Will the Minister of Railways be pleased to state:

(a) whether some hundred members of the Northern Railway traffic staff at Ghaziabad struck work on 31st January, 1959;

(b) if so, the circumstances leading to this strike;

(c) the loss incurred on this account; and

(d) the stops taken by Government in this regard?

The Deputy Minister of Railways (Shri Shahnawaz Khan): (a), (b) and (d). One Shunting Jamadar on duty was assaulted at Ghaziabad at about midnight on 29/30th January 1959. On 30th January, 1959, the staff represented that proper arrangements should be made for their protection during the night hours failing which they would not perform night duty. They also demanded that one Sub-Inspector of the Railway Protection Force who was alleged to have some complicity m the assault, should be transferred elsewhere and that an enquiry should be held into the assault

It was decided that an enquiry into the assault should be held immediately by three officers of the Railway and the decision was made known to all. However, 44 employees went on strike at 6 P.M. on 31st January and resumed duty at 6 A.M. on the next day. The enquiry commenced on the 1st February. It was explained to the staff that action could be taken against the Sub-Inspector only after the conclusion of the enquiry. Not satisfied at this, the staff again went on strike at 6 P.M. on the 1st February. The strike was however, called off at 11-30 P.M. on the same date unconditionally.

The Report of the Enquiry Committee will be given due consideration and necessary action taken.

(c) Approximately Rs. 49,000.

This represents the direct loss accrued as a result of loss in passenger earnings due to cancellation of trains. additional expenditure due to diversion of passenger trains by longer routes, and hold-up of passenger trains as well as detention to goods trains, shunting engines and wagons in Delhi area and neighbouring stations on Northern Railway. This does not include the indurect loss suffered as a result of the repercussion on goods and passenger train operation at other stations and big yards of Northern Railway and on contiguous Zonal Railways, as this figure is not readily available
