Smuggling of Gold

According to reports received by Government, gold continues to be sensitive to being smuggled into the country on account of the increasing differential between the international and domestic price of the metal.

Post lying vacant in branches of Reserve Bank of India

(b) and (c). The Reserve Bank of India have reported that it has not been possible to fill up the vacancies in the officers' cadre on account of writ petitions filed by the employees/employees' Association against direct recruitment and departmental promotional system in the bank. Since the matter is subjudice, no time limit for filling up the officers' posts can be determined at this stage.

In some of the offices of the bank, the process of filling up of vacancies in Class III is already in progress. The recruitment and

(b) The preventive and intelliposting of Class III staff is dependant on the availability of staff in Class IV cadre, especially in Mazdoor Cadre. In some of the centres, recruitment of Mazdoors has been delayed pending sponsoring of suitable and sufficient number of candidates by the employment exchanges. At some offices, the Local Class IV Unions are also obstructing preparation of waiting list for Class IV employees on one pretext or the other. Despite this, the bank is making every effort to fill up the vacancies as quickly as possible.
