THE MINISTER OF PARLIAMEN-TARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH): (a) It is a fact that such a statement was issued. But the Municipal Corporation of Delhi has denied that the storm water drains, etc. have not been cleared. The Corporation has informed that cleaning, deweeding and desilting of storm water drains, sewers and nullahs is a continuous process. Every year during the months of April, May and June, a special pre-monsoon drive is launched by the Corporation to ensure that rain water gets proper outlet during monsoons. Such a drive was launched this year as well. Vegetation from inside nullahs was also removed during the However, as a natural process, the vegetation grows again and silt also keeps on collecting in due course. But cleaning and desilting is done continuously by the Corporation.

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-MENT (SHRI R. V. SWAMINA-THAN): (a) Potential of Wealth in the form of Medicinal Herb Plants and rare botanical specimens found in Himalayan and other forest ranges in the country is well documented.

(b) Details are available in authoritative books like "Wealth of India" (Govt. of India Publication) and Chopra's "Indigenous Drug of India".

- (c) As per the Hathi Committee Report as adopted in Government Drug Policy, 14 plants have been identified which are the sources for essential drugs and the same Committee has recommended to increase cultivation of these 14 plant materials and production of active principles obtainable therefrom with updated technology;
- (d) Government of India have no plan to take over Pharmaceutical Laboratory at Ranikhet to develop Herbal Wealth in Kumaon Range of Himalayas on national level.

Prior to 21-4-1977 there was no practice of verification at the time of giving physical possession of the houses allotted on ad hoc basis on grounds of illness of family members or dependent partents. This practice was started from 21-4-1977 and from that date occupation slip is not given to the Government employees if the ground on which the same was sanctioned does not exist.
