Payment of Pension to Aged Pensioners

4735. SHRIT.R. SHAMANNA: Will the Minister of PARLIAMEN-TARY AFFAIRS be pleased to state:

(a) whether Government propose to take action to help aged Pensioners to draw pension as freedom fighters and also as an ex-Member of State Assembly or Parliament; and

(b) what steps Government propose to take to enhance the pension as assured by the Finance Minister?

THE MINISTER OF PARLIA-MENTARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH) : (a) Both the Houses of Parliament have passed during the current session of Parliament a Bill to amend Salary, Allowances and Pension of Members of Parliament Act, 1954 to authorise ex-MPs to receive the freedom fighters pension as also the pension for services rendered as Members of Parliament.

As regards pension for Members of the State Assemblies, the pension to Members of State Assemblies is regulated by the Acts of the State Government; and

(b) The Ministry of Finance have informed that the minimum service pension/family pension (including D.A. Relief) have been increased to Rs. 150/- per month and Rs. 140/per month respectively.
