Allowing Arab Sheikhs to Hunt Great Indian Bustard

4737. SHRI SATYASADHAN CHAKRABORTY: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether it is a fact that Government are going to allow hunting of bustards specially by Arab Sheikhs in order to gain some foreign exchanges for the Exchequer;
