so when Government intend to fix the price of the sheds on hire purchase basis;

- (d) whether Government are aware that the entrepreneurs in Okhla Industrial Etate Phases I and II are not paying monthly instalments; and
- (e) whether Government would spell out the period by which the entrepreneurs would be allotted the industrial sheds which Government had initially given to them ?

THE MINISTER OF INDUSTRY AND STEEL AND MINES (SHRI NARAYAN DATT TIWARI) : (a) No, Sir.

- (b) The matter is under active consideration of Ministry of Works Housing and Land & Building Department of Delhi Administration.
- (c) The entrepreneurs were asked to make ad-hoc payments towards rent/hire purchase in respect of these sheds at a much lower rate than the rent fixed in lease deed executed by the entrepreneurs, to avoid accumulation of arrears. Most of the entrepreneurs are not paying even the reduced rent. Since arrears have accumulated and the Corporation has to meet its repayment liabilities eviction proceedings have been initiated in some cases. There is no intention to victimise or harass any entrepreneur what soever.
- (d) Yes, Sir.
- (e) The examination of the proposal regarding allotment of sheds on hire-purchase scheme is being expedited.
