Ex-cadre Posts under Ministry of Defence

5241. SHRI T. S. NEGI: Will the Minister of DEFENCE be pleased

- (a) whether it is a fact that there are a number of ex-cadre posts under his Ministry and what are those excadre posts;
- (b) is it true that there is complete stagnation in promotion in some of the ex-cadre posts;
- (c) is it also a fact that the persons appointed in the posts of Caligraphists are still working in the same pay scale on which they were appointed even after rendering more than years of services; and
- (d) if so, what steps are being taken by Government to give justice to these categories of employees?.

THE DEPUTY MINISTER IN MINISTRY OF DEFENCE (SHRI K. P. SINGH DEO): (a) to (d). information is being collected and will be laid on the Table of House.

Transfer of Employees of United Commercial Bank

5242. SHRI K. LAKKAPPA; Will the Minister of FINANCE be pleased to state:

- (a) is it a fact that there is a good number of employees of United Commercial Bank serving at remote races of Himachal Pradesh for more than 4 years; if so, what is the normal period an officer is required to serve in such areas;
- (b) whether it is also a fact that in spite of transfer orders of some of those officers from the Calcutta Head Office in the months of June, 1982, their transfers have not so far been made effective by the Divisional Office, Simla;
- (c) how many such cases are pending with the Divisional Office, Simla and the reasons for such delay in carrying out the orders of the head office; and
- (d) when the said transfers are expected to be made effective.

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JANARADHANA POOJARY); (a) The United Commercial Bank have reported that an officer is required to serve in the rural areas for 7 to 8 years during his service career. The normal tenure of an officer at a rural rranch is 3 to 4 years but officers can be retained at a branch for a longer period if exigencies so require. There are a number of officers in Himachal Pradesh Division of the bank who have remained in the same rural branches for more than 4 years.

(b) to (d). The Head Office of the Bank had issued orders in June, 1982 for the transfer of 15 Scale-I officers. Due to certain administrative difficulties it has not yet been possible to give effect to these orders, but bank expect do so by the end of September, 1982.
