## Opening of branches of State Bank of India in Orissa

5248. SHRI ARJUN SETHI : Will the Minister of FINANCE be pleased to state :

- (a) the number of new branches of the State Bank of India proposed to be opened in Orissa during 1981-82;
- (b) whether some of the new branches of the State Bank of India are proposed to be opened in the rural areas; and
- (c) if so, their number and the places where they will be opened during the above period?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JA-NARDHANA POOJARY): (a) to (c). The State Bank of India added 28 branches to its branch network in Orissa taking the total number of its branches in the State to 290 as at the end of December 1981. As on that date the bank was also holding allot\_ ments/licences for opening 27 more offices in the State. Names of the centres to which these relate are being ascertained and will be laid on the Tablle of the House.

From the beginning of April 1982. the Reserve Bank have formulated a new branch expansion policy which aims at a banking coverage of one bank office, on an average, for 17,000 population in the rural and semi-urban areas. In pursuance of this objective, 350 additional allotments/licences are expected to be issued during the three years 1982\_83 to 1984-85 for opening rural semi-urban branchts at centres being indentified by the State Government in the 13 districts of Orissa. Some of these may get allocated to the State Bank of India. Their actual number and locations can, however, be known only when the branch expansion programme for Orissa finalised.

## Revolving Restaurant for Ashoka Hotel

5249. SHRI MOHAN LAL PATEL: Will the Minister of TOURISM AND CIVIL AVIATON be pleased to state:—

- (a) whether there is any proposal to set up a revolving restaurant on the top of Ashoka Hotel:
- (b) if so, what is the progress made in this regard and by when it will be ready;
- (c) what is the estimated cost of the said project; and
- (d) whether any other hotel in the country has such tower; if so, the details thereof?

THE MNISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHEED ALAM KHAN): (a) Yes, Sir.

- (b). The tower block of the revolving restaurant is completed upto fifth floor level. The scheme for the completion of the remaining work would be taken up for implementation subject to the satisfactory feasibility study and availability of resources.
- (c) The estimated cost of the project is Rs. 156 lakhs.

(d) While ITDC has no revolving tower restaurant presently in any of R. hotels, two other notels-Sea Rock Hotel and Hotel Ambassador both in Bombay have revolving towers, as per Government records.

Changes in Existing System on NCC

5250. SHRIMATI JAYANTI PAT-NAIK:

SHRI R. P. GAEKWAD:

Will the Minister of DEFENCE be pleased to state:

- (a) whether Government have taken a decision to make certain changes in the existing system of N.C.C.,
- (b) whether such changes have been made in conformity with the present system of education,
- (c) what are the new schemes added while introducing the new sys\_ tem; and
  - (d) the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF DEFENCE (SHRI K. P. SINGH DEO): (a) to (d). Government have not yet taken any decision to make any changes in the existing system of NCC training. However, the Central Advisory Committee for NCC in its 31st Meeting held in July, 1982 has made a number of recommendations on the reorganisation of the system of training in the NCC.

The basic change suggested by the Committee is that the Junior Division troops which have so far been attached to Senior Division Units should be formed into distinct and independent divisions. They have also recommendthe Instructor-Cadet ed that the Corps should be improved from the present 1:50 to about 1:36.

The Committee has also suggested rationalisation of the training programme to conform to the present 10+2+3 system of education. Under

the proposed rationalised system, the multiplicity of certificates for boys and girls in the Junior and Senior Division would be done away with and there will be only the following three certificates for all the NCC Cadets:—

- (i) 'A' certificate to be issued to the NCC Cadets of Junior Division, i.e.uto Class X.
- (ii) 'B' certificate to be issued to both the boys and girls attending NCC Training in 11th and 12th Classes (+2) stage), to be a part of Junior Division: and
- (iii) 'C' certificates to be awarded to the cadets of Senior Division ( 3 stage)

The Advisory Committee has also made a number of other recommendations to revitalise the N.C.C. These include introduction of a number of adventure oriented activities like Para-Sailing, Hang-Gliding, Water Skiing and Surf Riding, Rowing and Boat pulling. They have also recommended raising of additional Remount and Veterinary Squadrons as also Air Squadrons These recommendations are yet to be processed by Government for taking final decisions.

## Interest shown by Burundi to import Indian Products
