Raids on Premists of Liquor Merchants in Madras and Pondichtry

The residences of partners and premises of other connected persons were also searched at Madras and Mellore.

Prima-facie unaccounted cash and jewellery as under were seized:—

- (i) Cash Rs. 1,30,000 from the residence of Shri K. Narayan, partner of M/s. Ganapathy and Co.
- (ii) Cash Rs. 10,000 and jewellery with gold contents weighing 2287 grams approximately from the locker in the name of Shrimati Parvatamma w/o Shri Subbarama Reddy.
