(a) whether any loans/advances have been sanctioned to private hotel industry in Delhi, Madras, Bombay and Calcutta recently by (i) the Central Government, (ii) Public Financial Institutions or (iii) Nationalised Banks in 1982; and

(b) if so, the details thereof with amount of loan and the name of the Hotel/Company?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JA-NARDHANA POOJARY); (a) and (b). In the year 1982 (January—July), the Central Government has not sanctioned any loan for hotel projects in the private sector in Delhi, Madras, Bombay & Calcutta. The public financial institutions, namely, Industrial Development Bank of India (IDBI), Industrial Finance Corporation of India-(IFCI), Industrial Credit and Investment Corporation of India (ICICI), Life Insurance Corporation of India (LIC) and General Insurance Corporation of India (GIC) have sanctioned loans for a hotel project in the private sector in Delhi during the year 1982. These financial institutions have not sanctioned any loans during the year 1982 for hotel project in the private sector in Madras, Bombay and Calcuta. Details of the sanctions made to the hotel project in Delhi in the year 1982 are given in the attached statement.

As ragard assistance sanctioned by the Banks, although some sanctions have been made to hotel projects in the private sector during the vear 1982 by some of the public sector banks, the details are not capable of being furnished in accordance with the provisions of the statutes governing public sector banks and in conformity with the practices and usages customary among the bankers.
