ly visited India to discuss collaboration between the two countries in the nuclear field; and

(b) if so, the results of the discussions?

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) and (b) A four member delegation from the German Democratic Republic visited India from June 6 to 9, 1982 to hold preliminary discussions on a proposed agreement for Co-operation in peaceful uses of atomic energy. The discussions were in conclusive.

Introduction of television in North Eastern Region

- 959. SHRI AJOY BISWAS: Will the Minister of PLANNING be pleased to state:
- (a) whether Government are aware that the North Eastern Council has sought the Planning Commission's approval of Rs. 28 crore to introduce television in that region in the shortest time and involving minimum expenditure;
 - (b) if so, details thereof;
- (c) sters taken by Government in this regard; and
- (d) if no steps have been taken, the reasons thereof?

THE MINISTER OF PLANNING (SHRI S. B. CHAVAN): (a) to (c) A scheme regarding the coverage of TV and strengthening of sound broadcasting system in the North Eastern Region has been worked out. The fund requirement of the scheme for the radio and television segments during the Sixth Plan period is Rs. 23 crores. Out of this, the share of the North Eastern Council would be Rs. 7 crores. The proposal has been supported by the Planning Commission.

(d) Does not arise.

Reduction of period of service of Government employees to reduce unemployment

960. SHRI MOHAMMAD ASRAR AH-MAD: Will the Minister of HOME AF-FAIRS be pleased to state:

- (a) whether in view of acute unemployment in the country, Government have formulated any scheme to reduce unemployment by reducing the period services of Government employees from 30 years to 20 years or so:
 - (b) if not, the reasons therefor;
- (c) whether Government have formulated any other scheme to meet the situation of unemployment in the country; and
 - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI P. VENKATSUBBAIAH): (a) and (b) The Central Government emp'oyees are not retired after completion of a sepcified period of service. They are retired, with certain exceptions, on the last day of the month in which they attain the age of 58 years. As such, the question of reducing the period of service does not arise.

(c) and (d) The Sixth Five Year Plan includes a number of measures for generating more employment, such as (a) provision of adequate outlays for labour intensive sectors like Agriculture, Irrigation, Village & Small Industries, etc; (b) Fiscal, Excise and other incentives for development of small industries; (c) preference to labour intensive technologies and processes for production of goods and services wherever feasible; (d) step-up in the rate of economic growth; (e) disaggregated approach for manpower planning and employment generation; and (f) promotion of self-employment on a large scale.

उद्योग तथा इस्पात और खान मंत्री (श्री नारायण दस्त तिवारी): (क) से (ग) खादी तथा ग्रामोद्योग आयोग के केन्द्रीय कार्या-लय में खादी ग्रामोद्योग भवन, नई दिल्ली के कर्मचारियों के व्यक्तिगत मामलों को निपटाने में कोई अनुचित विलम्ब नहीं हुआ है। फिरभी आयोग में मामले कुछ समय से अनिणीत है। एक मामला कर्मचारियों की वरिष्ठता सूची में आर्थिक रूप से संशोधन करने के सम्बन्ध में हैं और इस पर श्रम आयुक्त दिल्ली दवारा दिए हुए निर्णय को ध्यान में रखते हुए विचार किया जा रहा है। दूसरा मामला जिसके बार में एक औद्योगिक विवाद उठाया गया है, एक कर्मचारी की वरिष्ठता/ पदान्नित से सम्बन्धित है और यह 1979 से अनिणीत है।

विलम्ब को सामान्य नियंत्रण रोकने के उपाय किए जा रहे हैं आयोग सभी अनिर्णीत मामलों को शीघृता से निपटाने का प्रयत्न कर रहा है।

Price of Maruti Cars

- 962. SHRIMATI KISHORI SINHA: Will the Minister of INDUSTRY be pleased to state:
- (a) whether Maruti Udyog Ltd. has decided to have technical collaboration with M/s. Suzuki (Japan);
- (b) whether under this collaboration low-priced cars would be manufactured; and
 - (c) if so, the details thereof?

THE MINISTER OF INDUSTRY AND STEEL AND MINES (SHRI NARAYAN DATT TIWARI): (a) Maruti Udyog Limited has applied to the Government for approval of their proposed collabora-Suzuki Motor Company tion with Ms. Limited of Japan.

(b) and (c) The objective of Maruti Udyog Limited is to manufacture modern, fuel efficient, automobiles at economical prices employing economies in scale manufacture. The actual price of vehicle will depend on the investment to be made, the phased manufacturing programme, extent of in-house manufacture, rates of customs and excise duty etc.

Study of programme evaluation organisation about gap in availability of infrastructure in backward areas

- 963. DR. SARADISH ROY: Will the Minister of PLANNING be pleased to state:
- (a) whether the study of the Programme Evaluation Organisation (PEO) has highlighted 'the serious gaps' in the availability of infrastructure in backward areas; and
- (b) if so, what steps Government have taken such as introduction of new railway lines and other communication systems in the backward areas?

THE MINISTER OF PLANNING (SHRI S. B. CHAVAN): (a) Yes, Sir. An Evaluation Study on Concessional Finance and Other Incentives in Industrially Backward Areas conducted by Programme Evaluation Organisation reveals serious gaps in the infrastructure in such areas.

(b) To remove gaps in the existing infrastructure in backward areas, projects such as new railway lines and other communication systems are being considered from time to time for inclusion in the Five Year Plans and Annual Plans subject to availability of resources.
