Thefts in Khadi Gramodyog Bhawan

Will the Minister of INDUSTRY be pleased to state:

(a) whether cases of thefts in the Khadi Gramodyog Bhawan have lately been on the increase;

(b) if so, the number of theft cases detected during the last six months stating the cost of the articles involved; and

(c) the measures taken to check these thefts and to bring the persons concerned to book?

THE MINISTER OF INDUSTRY AND STEEL AND MINES (SHRI NARAYAN DATT TIWARI): (a) and (b) Five (5) cases of theft each were detected in the Khadi Gramodyog Bhawan, New Delhi, during the years 1979 and 1980. In 1981 nine (9) cases of theft were detected. During the last six months (January— June, 1982) no case of theft was detected.

(c) Salesmen at the counters have been directed to be more vigilant during rush hours. During the Special Rebate Sales period when there is a heavy rush of customers more persons are employed at the counters. A Watchman has been posted at the gate to watch the customers and to prevent shoplifting. Besides, two or three persons are also deployed on the floor of the Bhawan to assist the customers and to keep a watch on them.
