(d) what are the main features of this Institute ?

THE MINISTER OF STATE OF THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL) : (a) to (d). The revised project report for the establishment of the proposed Sheikh Zayed Institute of Petroleum Studies and Chemical Engineering is under examination of the University Grants Commission.

Disabled Officers Employed In India's Embassies

1158. SHRI N. DENNIS : Will the Minister of EXTERNAL AFFAIRS be pleased to lay a statement giving the details of disabled officers employed in India's Foreign Embassies, and state :

(a) the ranks they held in service; and

(b) the countries in which they are serving ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P.V. NARASIMHA RAO) : (a) and (b). The required information is being collected from our Missions abroad and will be laid on the Table of the House as soon as available.

Delhi Administration Panel Of Ad Hoc Teachers

1159. SHRI R. L. P. VERMA : Will the Minister of EDUCATION AND CULTURE be pleased to state:

(a) whether it is a fact that a panel of *ad hoc* teachers was drawn by Delhi Administration in 1973-74 on the basis of interview.

(b) if so the number of teacher with their names seniority-wise who

are in the "Left-out panel of ad hoc teachers 1973-74" ;

(c) whether the Lt. Governor of Delhi has issued orders recently to absorb the entire panel of left out ad hoc teachers without any delay ; and

(d) if so, out of them (left-out panel of ad hoc teachers 1973-74) how many have so far been absorbed with their names as also a probable date by when the rest are likely to be absorbed ?

THE DEPUTY MINISTER IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRI P. K. THUNGON) : (a) Yes, Sir.

(b) As reported by the Delhi Administration, all the 35 candidates selected out of a total of 44, ad hoc teachers who appeared for interview before the Staff Selection Board, have been absorbed. This panel was prepared only to accommodate such ad hoc teachers who were appointed by the Department during the preceding 3-4 years.

(c) No, Sir. On a representation received from the 9 teachers who were not selected by the Staff Selection Board as mentioned in (b) above, the Lt. Governor, Delhi had issued instructions to allow them to appear before the interview board in future vacancies along-with other candidates in relaxation of the normal employment exchange procedure, etc.

(d) Out of 9 teachers mentioned in (c) above, 4 have already been selected/appointed. One Smt. Urmila Devi Sharma has recently appeared for interview for the post of Language Teacher (Hindi). Remaining 4 viz. Smt. Sushila Niwani, Smt. Shaheen Parveen, Smt. S. Wheeler and Smt. Rita Bagai would be given a chance to appear for interview alongwith

other candidates as and when vacancies in the concerned categories of teachers posts arise.

एशियाड-82 के दौरान दिल्ली के छात्रों को छुट्टियां

1160. श्री फूलचंद वर्मा : क्या शिक्षा और संस्कृति मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या एशियाई खेलों के अवसर पर दिल्ली के छात्रों को छुट्टियां घोषित करने का कोई प्रस्ताव है ;

(ख) यदि हां, तो क्या पड़ोसी राज्यों, मुख्यतः उत्तर प्रदेश और मध्य प्रदेश के छात्रों की भी छुट्टियां घोषित करने का विचार किया गया है ;

(ग) यदि नहीं, तो क्या सरकार राज्य सरकारों से इस प्रस्ताव पर विचार करने का आग्रह करेगी ; और

(घ) तत्संबंधी पूर्व ब्यौरा क्या है ?

शिक्षा और संस्कृति तथा समाज कल्याण मंत्रालयों में राज्य मंत्री (श्रीमती शोला कौल) : (क) एशियाई खेलों की विशेष आयोजन समिति के अनुरोध पर दिल्ली के शैक्षिक प्राधिकारियों ने 1982 में स्कूलों और कालेजों में शीत कालीन अवकाश को इस ढंग से पुनः समायोजित करने का निर्णय लिया है कि यह अवकाश 1982 के एशियाई खेलों की अवधि के साथ साथ हो ।

(ख) मध्य प्रदेश की राज्य सरकार ने 1982 में शीतकालीन अवकाश को एशियाई खेलों की अवधि के साथ साथ पुनः समायोजित करने का निर्णय लिया है । उत्तर प्रदेश सरकार ऐसे निर्णयों के पक्ष में नहीं है । राजस्थान और हरियाणा की सरकारों ने इस संबंध में अपने अंतिम निर्णय से मंत्रालय को सूचित नहीं किया है ।

(ग) और (घ). एशियाई खेलों की विशेष आयोजन समिति के आग्रह पर जून, 1981 में राज्य सरकारों/संघ शासित क्षेत्र प्रशासनों से अनुरोध किया गया था कि वे अपने स्कूलों और कालेजों में शीत कालीन अवकाश को इस ढंग से पुनः समायोजित करें कि यह अवकाश 1982 के एशियाई खेलों के साथ साथ पड़े । कई राज्यों से प्राप्त उत्तरों के आधार पर जिनमें उन्होंने अपने शीतकालीन अवकाश को पुनः समायोजित करने में कठिनाईयों का उल्लेख किया है और इस स्थिति को ध्यान में रखते हुये कि एशियाड-82 के दौरान दिल्ली में इन राज्यों के छात्रों के ठहरने के लिये कोई विशेष प्रबंध नहीं किये जा सकते, राज्य सरकारों/संघ शासित क्षेत्र प्रशासनों (दिल्ली को छोड़कर) को नवम्बर, 1981 में सूचित किया गया था कि सरकार अपने पहले के सुझाव पर जोर नहीं देगी ।

Summit meet of Industrial Powers at Versailles

1161. SHRI MADHAVRAO SCINDIA : Will the Minister of EXTERNAL AFFAIRS be pleased to state the outcome of the three-day summit meet of the seven leading industrial powers held in Versailles in the 1st Week of June, 1982, especially in so far as it effects India's economy ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO) : The Versailles Summit did address itself to the question of relations of developed countries with the developing countries without naming any particular country. A positive feature discernable in the Declaration related to the acceptance of the launehing of global negotiations, as a major political objective and the recognition of the importance of maintaining a high level of financial flows and
