- (a) whether Central Government are assisting the State of Kerala in construction of hostels for working women: and
- (b) if so, the details regarding the financial assistance granted to the State during the last three years and the performance thereon?

DEPUTY MINISTER THE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRI P. K. THUNGON): (a) Yes, Sir.

Fare Meters of Taxis and Auto Rickshaws

1168. SHRI S. M. KRISHNA: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether in view of the approaching Asian Games the fare meters of taxis and autorickshaws are proposed to be calibrated;
- (b) if so, the reasons for not doing the same by now when the last revision of fares was made about a year ago; and
- (c) when it is likely to be done especially in view of the fact that the drivers over charge the passengers?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING TRANSPORT AND SHRI SITARAM KESARI): (a) to (c). in Delhi the last calibration of meters was undertaken in March 1979 and completed in 14 month. The State Transport Authority Delhi Administration, taking into account various factors including time involved in the re-calibration of the large number of meters, had decided in July 1981 that the existing

meter calibration should be allowed to remain and that the present Fare Charges may be on the conversion charts. It has been made compulsory on the part of the Auto-rickshaw driver to prominently display the chart in-side the vehicle. Traffic Police Authorities as also the Deputy Director Transport (Enforcement) are assigned the Job of attending to any complaint at over- charging, as may be received.

Guidelines to States to implement New-20-Point Programme
