

### Restructuring and reorganisation of shipping Corporation of India

2419. SHRI JAGDISH TYTLER: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

(a) whether the Shipping Corporation of India is being restructured and reorganised after the Mogul Line was amalgamated into it;

(b) details of the restructuring and reorganisation; and

(c) how this restructuring is going to effect the Government?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI VEERENDRA PATIL): (a) In the light of the recommendations made by the Fazal Committee, the question of restructuring the Shipping Corporation of India and Mogul Lines is under consideration. However, no decision has been taken in the matter so far.

(b) and (c). Do not arise.

### Increase in line capacity of Railway

2420. SHRI JAGDISH TYTLER: Will the Minister of RAILWAYS be pleased to state:

(a) whether the Government are aware of the fact that a crisis is brewing for which immediate steps have to be taken to increase the line capacity of the Railways to take on the extra burden in terms both of passenger and freight traffic; and

(b) if so, the steps being taken or being proposed to eradicate this crisis situation?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) and (b). Development of capacity on the Trunk Routes is taking place but subject to availability of funds. The process will be accelerated if more funds are made available under the Plan-head Traffic Facilities.

### Archaeological finds in Tamil Nadu

2421. SHRI N. DENNIS: Will the Minister of EDUCATION AND CULTURE be pleased to lay a statement regarding the details of archaeological findings made by the Central Archaeological administration in Tamil Nadu during the last three calendar years?

(b) if so, the number of posts in Water Filtration Plants in the said Divisions upgraded; and

(c) if not, the reasons for non-implementation despite specific directives of the Ministry to implement within three months?
