Establishment of wildlife institute of India in M. P.

2516. DR. VASANT KUMAR PANDIT:

SHRI R. P. GAEKWAD:

Will the Minister of AGRICUL-TURE be pleased to sctate:

(a) whether Government have decided to establish a Wildlife institute of India in Madhya Pradesh; (b) whether the United Nations Development programme and FAO have agreed to provide the funds necessary for this Institute;

(c) if so, the details thereof;

(d) whether Government have decided to establish the Institute at Jabalpur;

(e) if not, the reasons thereof; and

(f) what courses and research would be initiated in the Institution regarding conservation and management of Wildlife and studies in all respects?

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-MENT (SHRI R. V. SWAMI-NATHAN): (a) The Wildlife Institute of India is being started at Dehra Dun, to begin with, by merging the existing Directorate of Wildlife Education and Research already there. The final location of the new Institute has not been decided, so far.

(b) and (c). The United Nations Development Programme assistance to the extent of US \$ 1 million is expected in the form of experts specialized faculty and equipment including some transport.

(d) and (e). No decision about the final location of the Institute has been taken so far.

(f) The Institute would engage mainly in the following four types of activities:----

- (a) Traning;
- (b) Research;
- (c) Publications, and

(d) Consultancy.

Training would consist of postgraduate diploma courses for forest officers as well as for graduates seeking specialised training in wildlife management. There would also be

field officers separate courses for at the level of Range Officers. In addition, facilities for research out research scholars to carry leading award of to the a PHD. Degree would ::: 50 be developed. Short-term o ientation and refresher courses would also be arranged. Research would basically concentrate on applied research of direct relevance to management and planning resources.

Cost of production of foodgrains vis-avis support price

2517. SHRI XAVIER ARAKAL: Will the Minister of AGRICUL-TURE be pleased to lay a statement showing:

(a) the total production of foodgrains in 1982;

(b) the cost of production per quintal of wheat, rice, sugarcane etc. for the last three years;

(c) what is the price per quintal paid to the farmers for the last three years; and

(d) what is the subsidy given to farmers for the last three years?

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-R V. SWAMINA-MENT (SHRI THAN): (a) Firm estimates of production of foodgrain crops for the year 1981-82 have not yet become available from the States. However, on the basis of present indications, production of foodgrains during 1981-82 is expected to be around 132 million tonnes.

(b) A statement shownig cost of production per quintal of wheat, rice (paddy) and sugarcane for the last three years i.e. 1977-78, 1978-79 and 1979-80 for which data are available is given in statement I.

(c) Price per quintal announced by the Government as procurement/ minimum support prices of wheat, rice and sugarcane is given in statement-II.

(d) The Government has been giving subsidy on fertilizers with a view to maintain selling prices at a reasonable level and to induce their use by the farmers. Total subsidy given for fertilizers for both imported and indigenous and on internal freight for the last three years is as under:
