(iv) The Ministry of Rural Development is also launching a new scheme of Development of Women and Children in Rural Areas. This scheme will cover 500 blocks. The objectives of the scheme is to focus attention on the women members of the families from target groups comprising small/ marginal farmers/agricultural, nonagricultural and landless labourers, rural artisans, Scheduled Castes and Scheduled Tribes so as to increase their income and also to provide supporting services needed to enable them 'o take up income genera'ing activities. A sum of Rs. 200 lakhs exists for the scheme in the Budget Estimate 1982-83.

(v) Socio-economic programme of Central Social Welfare Board.

The Central Social Welfare Board has a Socio-economic programme for providing the needy women such as economically backward, destitutes, widows, deserted and also physically handicapped persons with opportunities for 'Work & Wage' affording facilities to them to engage themselves in full time or part time work for supplementing the meagre income of the families. Under this programme the Board provides financial assistance in the form of grants to the voluntary institutions for setting up various categories of units such as:---

1. Production Units for Small Industrial items.

2. Units as ancillary to large industries:

3. Handloom Units.

4. Handicrafts units.

5. Self-employment units.

6. Agro-based units: -

(i) Dairy Units.

(ii) Piggery.

(iii) Goat rearing.

(iv) Sheep-breeding.

The allocation for this programme for the year 1982-83 is Rupees 275.00 Lakhs.

> Construction of B.G. by-pass at Kumedpur
