THE DEPARTMENT OF PARLIA MENTARY AFFAIRS (SHRI MAL-LIKARJUN): (a) Ministry of Railways' order dated 4-1-82 modified their earlier orders dated 15-2-60 which allowed higher seniority to the Special Class Apprentices recruited between 1-1-42 and 31-12-59 and the affected officers had filed a writ petition in the Delhi High Court.

- (b) Yes, but the Government have filed an S.L.P. in the Supreme Court against this judgement.
- (c) The decisions impinging on service matters pertaining to railway empolyees are taken by the Ministry of Railways with the fullest deliberation and in accordance with the procedures laid down including consultations with the Department of Personnel, Ministry of Law & Union Public Service Commission where ever suco consultations are required.

Representation from Cooperative Society, Allahabad

3888. SHRI K. A. RAJAN: Will the Minister of RAILWAYS be pleased to state:

- (a) whether he has received any representation from Harijan, Minority, Backward class Venders Labourers Cooperative Society Ltd., Allahabad dated 21st September, 1982,
 - (b) if so, the details thereof;
- (c) whether the points raised have been considered and reply givn; aned
 - (d) if so, the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIA MENTARY AFFAIRS (SHRI MAL-LEKARJUN): (a) Yes. However, the representation was dated 5-1-81 with enclosures and handed over on 21st September, 1982.

(b) to (d). Some allegations have been made against the existing contractors and request made for allot-

ment of some catering facilities to the Society. The issues are under examination and the information will be laid on the table of the Sabha.

New Mangalore Harbour

3889. SHRI T. R. SHAMANNA: Will the Minister of SHIPPING AND TRANSPORT be pleased to slate:

- (a) whether the New Mangalere Harbour has been completed in all respects:
- (b) if not, when it was to be completed as per schedule:
- (c) when it is expected to be completed:
- (d) whether a big beam of 120 metres has collapsed there: and

'THE MINISTER OF SHIPPING AND TRANSPORT (SHRI C. M. STEPHEN): (a) to (c), All major works envisaged during the first and second stages of development of New Mangalore Port were completed 1975 and 1980 respectively, with the exception of a few minor ancillary works not connected with Port's operation. Even these works are expected to be completed by 31st March, 1983.

- (d) Yes: a concrete girder of transit shed under construction came down on 28 September, 1982. It has since been replaced by a new girder.
- (e) The mishap occurred due the negligence of the contractor's workmen. The loss was of the contractor and not of the port.
