RAHIM): (a) and (b) The Missions and Posts abroad are staffed according to the prescribed norms, taking into account the quantum of work involved (including the work relating to the welfare of Indian emigrants) and the budgetary constraints. The strength is reviewed from time to time in the light of these norms after on-the-spot studies by teams of Foreign Service Inspectors and other administrative means. The criteria for selecting personnel are mainly functional requirements; (ii) experience, competence and aptitude cluding the knowledge of the region and of foreign languages.

Construction of Raliway line to Porbander

Indian Seamen exploited during Falklands war

3962. SHRI R. L. BHATIA: Will the Minister of SHIPPING AND TRANS-PORT be pleased to state:

- (a) whether his attention has been drawn to the news item captioned Indian seamen exploited during Falklands war' appearing in the 'Tribune' Chandigarh dated the 11th October 1982; and
- (b) if so, facts thereof and reaction thereto?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI C. M. STEPHEN): (a) Yes.

(b) S. S. Uganda is a British Flag Ship owned by British India Steam Navigation Co, and managed by Penisular and Oriental Lines. This ship is used for educational cruises for children between London and Mediteranean Ports. Except the officers and petty officers; the entire crew employed on board S. S. Uganda was being recruited from Calcutta. The total Indian crew employed on the ship was 232 before the out-break of Falkland war.

On the outbreak of the war, the British Government requisitioned this ship for converting it into a hospital ship for utilisation in the war zone. The Indian seamen were asked they would volunteer for service in the war zone and promised National Maritime Board Wages, which applicable to Indian seamen recruited from India on Indian and foreign ship under Indian Articles of Agreement plus 150 per cent of the NMB wages. 166 Indian seamen declined to continue and were repatriated to India. A large number of Indian seamen at Calcutta volunteered to join the ship at the promised wages and finally 64 were signed on and were
