THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A, A, RAHIM): (a) to (d) Government has seen press reports to the effect that a meeting of 34 human rights organizations from 12 countries from the ESCAP region was held in New Delhi in October Reportedly the above meeting was organized by the Human Rights Committee of the non-governmental organization, Iaw Association Asia and the Western (LAWASIA). Since the meeting was restricted to non-governmental organization, Government of India did not participate and has not received any details regarding the subjects discussed.

## X.Ray unit in Orthopaedica Casualty Departments, Safdarjung Hospital

- (a) whether two-X-Ray units each Orthopaedic Department, and Casualty Department Safdarjung Hospital have been out of order for quite sometime:

- (c) whether radiographers have to work two shifts and X-Ray machines. most of which are old and posethreat of leakage are over-burdened;
- (d) whether X-Ray machines are checked regularly for leakages in their tubes which endanger both technicians and patients; and
- (e) whether technicians have to operate portable X-Ray units without filters thereby increasing risk to radiation exposure?

- SHANKARANAND): (a) and **(b)** Two of the X\_ray units in Orthopaedics Department were out of order for a short period and have since been put into operation, One X-ray machine in Casualty Department is out of order and steps have been taken to get it repaired.
- (c) Radiographers are not forced to work more than 61 hours a day. X-ray machines are suitably protected against leakage.
- (d) The X-ray machines have been checked by BARC and protective arrangements are provided to prevent any leakage.
- (e) X-ray machines are provided with suitable filters.

## Jail Road Flyover
