

Cantonment side together with street lights?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI SITA RAM KESARI): (a) and (b) The Jail Road flyover has been made trafficable as per schedule and is planned to be opened to traffic shortly. However, the ancillary works like providing drainage etc. are scheduled to be completed as per the contract in June 1983.

(c) According to M.C.D. out of 14 spans of the stilt portion of the flyover on Delhi Cantt. side 8 spans have been cleared of debris and landscaping is being done. The clearance of debris in the balance spans of the flyover is being progressively carried out along with the ancillary works. Proposals for land use in this area are under consideration.

(d) and (e) The width of the approaches for the flyover was reduced from 92 ft. to 76 ft. to provide adequate circulation space in front of shops in the interest of market. However, footpaths have been provided at ground level and not in the approaches. Therefore, there is no proposal of providing any staircase from the approach portion in the middle of the market.

(f) The space in front of the shops is planned not to be used by vehicular traffic. This will be suitably paved/metalled alongwith the completion of ancillary works. Arrangements for street lighting involving shifting of poles as necessary and improvement of space in front of the shops is connected with the overall land use proposals in this area and are under consideration.

(g) The Jail Road has been connected via flyover with the service road constructed on Delhi-Cantonment side where necessary street lighting arrangements have also been provided.

(b) whether the project was scheduled to be completed on time for the ASIAD '82 as well as new Electric Ring Railway so also to reduce the congestion on the Chelmsford Road; and

(c) if so, steps taken to have the land vacated from P & T and to ensure the opening of the second entry on time?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) to (c). Due to delay in vacation of the quarters by P & T Department the work of provision of entry/exit for the new Station Building on Ajmere Gate side at New Delhi Railway Station was adversely affected. All the quarters have since been vacated, and except for one quarter, all the rest have since been handed over to the Railways and the same dismantled. The work of providing the road is in progress and expected to be completed on time.
