THE MINISTER OF STATE OF THE MINISTRIES OF CIVIL AVIATION AND CIVIL SUPPLIES (SHRI BHAGWAT JHA AZAD): (a) Yes, Sir.

(b) The terms of lease are:

(1) Rent to be paid: Rs. 19,623.60 p.m.

(2) Day-to-day maintenance is the responsibility of Air India.

(3) Colour washing once a year and repairs as and when nec ssary are the responsibility of the landlord;

(4) If colour washing/repairs are not carried out as per the terms, Air India can get them carried out subject to the condition the cost of such works shall not exceed one month's rent.

The annual expenditure on day-to day maintenance is Rs. 21.120/-. No major repairs have been carried out in this building during 1980-81 and 1981-82.
