The all India term lending Financial Institutions, including the Industrial Development Bank of India (IDBI) do not make State-wise allocation of funds for assistance to industrial units. Flow of assistance from the financial institutions to any particular State is essentially determined by the number of application for assistance received from the State which in turn depends on the level of entrepreneurial activity in different States, and locational decision of the entrepreneurs. The locational decision of the entrepreneurs is determined by factors such as availability of raw material, skilled labour power supply basic infra-structural facilities and proximity to market. The financial institutions extend assistance in accordance with national priorities, to projects which are found economically and financially viable and technically feasible Incidentally, the latest IDBI Report on Development Banking in India relates to the vear 1980-81.
