spinning spindles. The replacement is confined mostly to the preparatory actions and drawing and spinning ections in the mills. In the weaving and the finishing sections the progress of modernisation in Jute industry negligible.

The nationalised units of NJMC have taken up a modernisation programme of replacement/renovation and also installation of D. G. sets to re-coup losses caused by power failure. Several private mills, also have imported and installed new technology machines for diversification in the reas of manufacture of decorative fabrics and high grade yarn..

In the context of the socio-economic structure prevailing in India, modernisation of Jute industry have been confined to replacement of old/delapped machinery by the new machines of existing technology and renovation of in talled machinery of existing technology only. Modernisation in the en of capital-intensive, superior technology and of labour-saving nature has not taken place in jute industry, nor is it possible to introduce such new technology machines which would result in reduction in employment.

Loss Incurring Public Sector Units

4145. SHRI ANAND SINGLE Wil the Minister of FINANCE be pleased to state:

- (a) what are the new public sector units which have shown loss luring 1981-82; and
- (b) the remedial steps taken in tris direction?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PAT TABHI RAMA RAO): (a) Presumably the Hon'ble Member is referring to those enterprises which have either newly incorporated or taken over by the Government otherwise become Government companies and which have come into existence and have become operational in the recent past.

The detailed assessment of profitability of the Central public sector enterprises during the year 1981-82 based on the audited accounts in the "Public Enterprises Survey for 1981-82" will be placed before the Parliament in the ensuing Budget Session. However, as per a quick assessment on provisional data, it is seen that new public sector enterprises incorporated or taken over by the Government during the last 3 ears, taken together, have made overall net profit. Of these who likely to incur losses in 1981-82, following could be mentioned:

- (1) Bengal Chemicals & Pharmaceuticals Ltd.
- (2) Bharat Process & Mechanical Engineers Ltd.
- (3) Cycle Corporation of India Ltd.
- (4) National Bicycle Corporation of India Ltd.
- (5) National Jute Manufacturing Corporation Ltd.
- (b) The following remedial have been taken towards improving the operational efficiency of these en-1 rprises:
 - (i) All the enterprises have been asked to prepare their action plan to increase production and improve the profitability in 1982-83;
 - (ii) detailed performance review is undertaken by the respective ministries at periodic intervals covering the various aspects of production capacity utilisation, operational paramaters, etc. Steps are taken to improve the performance based on the outcome of such performance reviews.

Trusts Exempted from Income-Tax

4147. SHRI ANANTHA RAMULU MALLU: Will the Minister of FIN-ANCE be pleased to state:

- (a) the number of public and private trusts established during the last two years in the country, State-wise, which have been exempted from the Incometax:
- (b) the names and addresses alongwith their locations: and
- (c) the details regarding their annual income?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PATTABHI RAMA RAO): (a) to (c). Private trusts are not eligible for exemption from income-tax. Income derived from property held under trust wholly for charitable or ous purpose is entitled to exemption u/s 11 of the Income-tax Act. 1961. Subject to the requirements of sections 11 to 13 being fulfilled. In a generality of cases, the first accounting year for trusts established during 1980-81 would be 1981-82 relevant to the assessment year 1982-83. Similarly trusts established during 1981-82 will have their first accounting year as 1982-83 and first assessment year 1983-84.
