The Minister of Information and Broadcasting (Dr. Keskar): Plan Publicity in the States is mainly the function of the State Government concerned. The Punjab Government have made a provision of Rs. 5-85 lakhs for Plan Publicity for the year 1950-60.

Under the Integrated Publicity Programme for the Second Plan, this Ministry is also responsible for giving general publicity to the Plan and development works included therein, on all-India basis, through its various Media Units. As the expenditure is not booked State-wise, it is not possible to give figures of expenditure incurred in Punjab under the Programme.
