## Filling up of General Category vacancia by Bank of Baroda

4300 SHRI HARISH KUMAR GANGWAR: Will the Minister FINANCE be pleased to state:

- (a) whether Bank of Baroda filling general category vacancies from amongst the employees available in the merit list in place of those who had refused to accept promotion from clerical to officers cadre;
- (b) whether this Bank is also filling vacancies in place of employees who had qualified in the written test and interview but resigned the Bank service amongst General Category employees:
- (c) whether this Bank is not filling vacancies of SC/ST employees in the above same cases and declaring the quota of their including their name in the final list; and
- (d) if so. what steps Government propose to take to ask the Bank to promote the next employees belonging to SC/ST in place of these who had resigned from the Bank service but their names were included in the final list of selected persons from clercial to officers cadre?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE JANARDHANA POOJARY): (a) to (d). The Bank of Baroda has reported that in case of promotion from clerical to officers cadre if a promotee employee from either the general or the reserved category refuses to accept promotion or resigns from the bank's service the resulting vacancy is filled in by the next available candidate in the merit list of the respective category. However, if SC/ ST employees are not available the vacancies are filled in by the general category candidates.

According to the bank all the available SC/ST candidates in merit list who were successful. the written test and interview in the current year have been promoted to officers cadre and that there is no waiting list of such candidates. The Bank has also reported that the backlog of unfilled vacancies reserved for SC/ST is carried forward to subsequent years in accordance with Government orders in order to safeguard the interest of SC/ST.
