1585. SHRI P. RAJAGOPAL NAIDU: Will the Minister of HOME AFFAIRS be pleased to state :

- (a) whether sub-plans were prepared for integrated tribal development; and
- (b) if so, the places where those plans were implemented?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHARRANJAN LASKAR) : (a) Yes, Sir.

(b) These plans are being implemented in tribal concentration areas of 17 States of and Union Territories.

Ertablishment of Production Facilities in India with Soviet Buy-back

(a) and (b) As a reslut of the deliberations of the Indo-Soviet Joint Commission held recently it has been agreed in principle to set up some projects in India with Soviet assistance and buy-back of the end-products by the Soviets. The matter is to be examined further by concerned agencies of both sides to develop concrete proposals.

Selection grade for prosecutors working in Delhi Administration

VENKAT-ASUBBAIAH): (a) to (d) According to the information received from Delhi Administration, the posts of Prosecutors are filled by promotion from among the Proscutors of the Directorate of Pro-secution. At present there is only one vacancy in the grade of Senior against which promo-Prosecutor tion from among the Prosecutor is being considered by Delhi Administration.
