Terrorists in North Eastern Rgion

SHRI K. MALLANNA:

Will the Minister of HOME AFFAIR be pleased to state :

- (a) whether there has recently been a change in the style of operations of terrorists in the North-Eastern region which has been causing great concern to the Central Government;
- (b) whether these terrorists in Manipur and Arunachal Pradesh have begun a drive against corruption and are killing those persons whom they identify as corrupt officials;
- (c) if so, what are the other changes in their style of functioning that have come to the notice of Government;
- (d) whether the Centre has suggested any measures to be taken to deal with the activities of the terrorists; and
- (e) the action Government have proposed to the state Governments to check this menace?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFA-IRS (SHRI NIHAR RANJAN LASKAR): (a) to (e) There hasbeen no marked change in the style of operations of terrorists in the North Eastern Region. However, in Manipur an organisation calling itself the 'Terrorist Suicidal Service' has come to notice in July 1982 for criculating letters to Ministers warning and Government officials. organisation also claimed nsibility for killing of two officers and the attempt to kill another officer in June-July, 1982. The Government of Manipur are aware of the development and have taken preventive steps in this regard.

No such activity has been reported from Arunachal Pradesh.
