Alleged Delay in Implementations of New Railway Project

1915. SHRI HARIHAR SOREN: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that there is an inordinate delay in the implementation of new railway projects that are being approved;

(b) if so, the reasons thereof;

(c) name of such new approved projects; and

(d) details of steps proposed to be taken by Government to expedite the implementation of those projects?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS AND IN THE DEPARTMENT OF PARLIAMEN-TARY AFFAIRS (SHRI MALLIKAR-JUN): (a) to (d). The implementation of new projects are affected due to shortage of funds. Funds available for on-going projects are not sufficient to progress them at a satisfactory pace. Due to serious constraint of resources it has been decided to concentrate the resources on a few ongoing projects and complete them at an accelerated pace within a reasonable period of time, so that the benefits of investment can flow to the public at an early date and the scarce funds do not remain locked up on unproductive half completed investments. Efforts are also simultaneously being made to secure more funds from the Planning Commission.
