Identification of Items .in Jammu and Kashmir for Boost of Exports

- (a) whether the Federation of Indian Exports Organisations (FIEO) has identified several items whose exports can be boosted from Jammu and Kashmir;
- (b) if so, what are the items identified; and
- (c) what steps have been taken by the Federation of Indian Export Organisations to help the J&K State to improve the exports of the items identified by them?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI SHIVRAJ V. PATIL) (a) and (b) Sir. The following items have been identified:

- (1) Handicrafts.
- (2) Leather based products,
- (3) Engineering products.
- (4) Textiles.
- (5) Sports goods.
- (6) Agro-based products.
 - (7) Carpets, and
- (8) Horticulture.
- (c) In order to improve exports from Jammu & Kashmir State and also to focus attention on the export potential of the identified items, a Seminar was recently

organised by the Federation of Indian Export Organisations in Srinagar in association with the Kashmir Chamber of Commerce & Industry.

Number of Aircraft Operating in Vavudoot

2073. SHRI NAVIN RAVANI: Will the Minister of CIVIL AVIATION pleased to state:

- (a) the number of aircraft operating in the third airline i.e. Vayudoot service;
- (b) whether Government are considering to acquire more aircraft for Vayudoot service and the number; and
- (c) if so, what is the latest postion in this regard and what are the reasons for delaying the decisions?

THE MINISTER OF STATE OF MI-NISTRIES OF CIVIL AVIATION AND SUPPLIES (SHRI BHAGWAT CIVIL JHA AZAD): (a) Vayudoot services are, at present, being operated with three aircraft.

- (b) Yes, Sir. The number of aircraft to be acquired has not been finalised as yet.
- (c) Government has constituted a Committee to recommend inter-alia the most suitable aircraft for Vayudoot operations, The recommendations of this Committee are likely to be finalised shortly.

Take over of Sick Units

Indo-U.K. Cooperation in Defence Field

2076. SHRI B. V. DESAI:

SHRI SUBHASH CHANDRA BOSE ALLURI:

Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that India and U.K. Governments have agreed to enhance their cooperation in sophisticated areas such as defence, etc.;

- (b) whether both the countries have decided that experts from the countries will meet periodically to explore ways of intensifying bilateral cooperation in the defence field marked by the manufacture of British equipments in India; and
- (c) if so, to what extent the U.K. Government has already provided sufficient knowledge and technology in the defence cooperation so far and whether experts from both the countires have already visited the places and the outcome of the results so far achieved?

THE DEPUTY MINISTER IN THE MINISTRY OF DEFENCE (SHRI K. P. SINGH DEO): (a) to (c) The British Secretary of State for Defence during his recent visit to India agreed that it should be possible to expand the areas of cooperation between the two countires. It was decided during the discussions that experts from India and United Kingdom would meet periodically to explore ways of intensifying cooperation in the field of defence. It is, however not in public interest to disclose further details in this connection.

Setting up of Fourth Pay Commission for Central Government Employees

- (a) whether Government are considering to set up Fourth Pay Commission for their employees; and
- (b) if so, when the decision could be expected alongwith other details?

THE MINISTER OF FINANCE (SHRI PRANAB MUKHERJEE) (a) and (b) In the ordinary meeting of the National Council (JCM) held on 13th and 14th May, 1982 the Staff Side had suggested to set up Pay Body to look into pay matters only of Central Government employees. This suggestion of the Staff Side is under consideration of the Government and no final view has emerged so far.
