THE DEPUTY MINISTER IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-MENT (KUMARI KAMLA KUMARI): (a) and (b). At present regular employees of the Food Corporation of India are paid overtime allowance on the same terms and conditions as are applicable to the Central Government employees, excepting for Maharashtra Region where overtime allowance is being paid as per provisions of the Bombay Shops and Establishment Act, 1948. of the staff unions of the Corporation have been demanding the payment of overtime allowance under the provisions of the Shops and Establishments Act of the respective States and the matter is under examination of the management of the Corporation.

(c) and (d). The new transfer policy is in the nature of administrative guidelines which do not envisage any one time transfer of large number of employees enmasse. Thus, the question of involving any large expenditure as a result of these guidelines does not arise.
