Development of Laland Fishery Resources

2302. SHRI K.A. SWAMI: Will the Minister of AGRICUL-TURE be pleased to state the details of measures taken and those under contemplation for intensive development of inland fishery resources?

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-MENT (SHRI R. V. SWAMI-NATHAN): Tanks and ponds constitute the main culturable inland

resources and have already been taken up for intensive development. Fish Farmers' Development Agencies set up in 108 districts in almost all the States as pilot projects envisage a package approach including reclamation of tanks and ponds for making them suitable for fish culture with Gorernment and institutional finance. The fish seed which is the basic input needed for fish farming is contemplated to be produced under World Bank assisted Inland Fisheries Project, (ii) Fish Farmers' Development Agencies' Fish Farms and (iii) National Fish Seed Programme on Commercial scale. In addition to these programmes under Centrally Sponsored Sector, the State Governments under their plan schemes are also assisting fish farmers both for the development of tanks and ponds and in fish seed supply.

Considering the importance of intensive inland fisheries the Central Government have provided in the Sixth Plan a sum of Rs. 18.90 crores for assisting the State Governments in the various programmes.

Enhancing Foodgrains Quota to Bibar in wake of Drought and other Natural Calamities

2303. SHRI D. L. BAITHA: Will the Minister of AGRICUL-TURE be pleased to state:

- (a) whether Government of Bihar have requested for allotment of sufficient quantity of food-grains to meet the acute scarcity condition prevailing in the State owing to serious drought;

- (c) whether it is a fact that fair price shops particularly in the rural areas do not get any allotment of foodgrains and in the urban areas also supply of foodgrains is very meagre : and
- (d) whether Government would consider the desirability to increase the quota of foodgrains to Bihar to tide over the un-precedented circumstances created by drought condition in the State; if not, the reasons thereof?

THE DEPUTY MINISTER IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-MENT (KUMARI KAMLA KUMARI): (a) and (b). Yes, Sir. The Government of Bihar have requested for allotment of I lakh tonnes of wheat and 50,000 tonnes of rice per month from the Central Pool to meet the increased requirements of their public distribution system arising out of drought situation in the State. The allocations made to the State Government from the Central Pool during the last three months were as under :-
