The International Rural Development Programme was introduced in 1978-79 in selected blocks. Only in 1980-81, the programme was extended to all the blocks in the No evaluation of the procountry. gramme on All-India basis has so far been made but some studies conducted in Gujarat and Rajasthan show that the programme is proceeding on intended lines.

### Effect of Rain on Rabi Crop Production

2338. SHRI B.V. DESAI: Will the Minister of AGRICULTURE be pleased to state whether the loss of the standing rabi crops and foodgrains during the rains in April and May, 1982 had caused setback to farm production and even rains in the month of August and September have also affected this ?

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-(SHRI R.V. SWAMINA-MENT THAN): The unseasonal rains during the latter part of April and first fortnight of May, in 1982 affected the standing and harvested rabi crops to

some extent in the States of Punjab, Haryana, Rajasthan and Uttar In spite of this, the food-Pradesh. grains production in 1981-82 was an all-time high.

The rains in the months of August and September, 1982 have been beneficial to the crops. However, some areas mainly in the States of Orissa, Bihar and Uttar Pradesh have had floods which affected the standing crops.

Inflation due to Increase in Procurement Price for Paddy

## SHRI SATYENDRA NARAIN SINHA :

Will the Minister of AGRICUL-TURE be pleased to state:

(a) whether it is a fact that increase in the procurement price for paddy has resulted in the cost push inflation in the country; and

(b) if so, what were the reasons for increasing the paddy price to Rs. 122 per quintal?

THE MINISTER OF STATE IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-MENT (SHRI R.V. SWAMINA-THAN): (a) No, Sir. There is no evidence of rise in general price level.

(b) The procurement price of paddy has been raised from Rs. 115/- per quintal for 1981-82 season to Rs. 122/per quintal for 1982-83 season with a view to take care of higher cost of production per quintal of paddy and to provide an incentive to the cultivators for augmenting production and for maximising procurement for meeting the increased requirement of public distribution system as also for replenishing buffer stock.

# Land in Dr. Mukherji Nagar

2340. SHRI ANAND SINGH: Will the Minister of WORKS AND HOUSING be pleased to state:

(a) what progress has been made towards the proposed transfer of title from Delhi Municipal Corporation to Delhi Development Authority in respect to the lands in Dr. Mukherji Nagar; and

(b) whether Government have fixed a time limit for getting the vacant possession of the Kingsway Camp lands from those beneficiaries who have been allotted lands in Dr. Mukherji Nagar ?

THE MINISTER OF PARLIA-MENTARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH): (a) Administrative approval of government to the transfer of the works of the redevelopment of the Hudson and Outram Lines of the Kingsway Camp in conjunction with the development of Dr. Mukherji Nagar from the Municipal Corporation of Delhi to the Delhi Development Authority has been issued on the 4th September, 1982.

(b) although no time limit has been fixed, Government is already seized of the matter.

# Encroachments on D.D.A. Lands in Dr. Mukherji Nagar
