THE MINISTER OF STATE IN THE MINISTRIES OF AGRICUL-TURE AND RURAL DEVELOP-MENT: (SHRI R.V. SWAMI-NATHAN): (a) Yes' Sir, the press report in the Indian Express dated September 23, 1982 has been seen. According to the published information reviewed by ICAR Scientists, Fusarium senitectum is an extremely common fungus in tropical and sub-tropical areas of the world, but as a saprophyte, and not as a pathogen of plants. It occurs in diseased plant parts as a containment and not as a casual agent of any disease. In India it has been found to be associated with leguminous crops such as soybean and gram (cickpea). As a saprophyte it can be isolated from varied type of substrates including seeds of wheat, maize, etc. However, it has so far never been demonstrated to cause disease in cereals such as wheat.

Thus the fear, in the light of our current knowledge, that Fusarium semitectum found associated with gummosis in Ku-Babul (Leucoena Leucocophala) is likely to pose a threat to "grass or wheat" appears to be unfounded

(b) The Indian Scientists are keeping vigil on the nature of association of the fungus with gummosis in the Ku-Babul.

संसदीय कार्य तथा निर्माण और आवास मन्त्री (श्री भीष्म नारायण सिंह): (क) से (ग) कुछ राज्यों में कुछ पाइलट परि-योजनाभ्यों के सिवाय ग्रामीरा स्वच्छता पर मभी तक बहत कम ध्यान दिया गया है। ग्रामीरा स्वच्छता राज्य का विषय है तथा योजनाएं राज्यों द्वारा बनाई तथा कार्यान्वित की जानी होती हैं। इस विषय के लिए केन्द्रीय क्षेत्र की कोई योजना नहीं है। फरवरी, 1982 में राज्य प्रतिनिधियों के साथ हए सम्मेलन में भन्तर्राष्ट्रीय पेय जल पूर्ति तथा स्वच्छता दशक (भ्रप्रैल, 1981 से माचं, 1991 तक) के दौरान 25 प्रतिशत ग्रामीए। जनसंख्या को सुलभ शौचालयों को मूहैया कराने का वास्तविक सक्ष्य स्वीकार किया गया था। ग्रामीएं स्वच्छता के लिए यूनिसेफ से भी सहायता उपलब्ध होने की सम्भावना है।

Beautification of Delhi by D.D.A.

THE MINISTER OF PARLIA-MENIARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH): (a) and (b). The D.D.A. has reported that some squatters have been removed from Nehru Place complex from the land required for development of a nodal

point for DTC on 7-9-82 and not on account of beautification drive for Asian Games. The DDA has stated that 101 persons have been allotted alternative sites in Sultanpuri.

Increase in prices of Flats constructed at Saket under Self Financing Scheme

The DDA has not revised the disposal cost fixed in respect of the dwelling units constructed under the first Self Financing Scheme at Saket, South Delhi.
