Andamans Forest

Family Planning in Orissa

2061. **Shri Chintamani Panigrahi:** Will the Minister of Health be pleased to state:

(a) whether the provision of Rs. 4.50 lakhs made for Orissa for 1959-60 in respect of family planning schemes has been fully utilised; and

(b) the nature of programmes over which this amount has been spent?

The Minister of Health (Shri Kar-markar): (a) The Government of Orissa have intimated that the provision for 1959-60 in respect of Family Planning Schemes was Rs. 3,28,905 and the estimated expenditure is about Rs. 293,950. The provision could not be fully utilised due to non-availability of whole-time medical personnel.

(b) The expenditure is on account of maintenance of 60 Rural Family Planning Centres, 28 Urban Family Planning Centres, One Family Planning Officer with her subordinate staff, One Family Planning Clinic in the S.C.B. Medical College, Cuttack and one Family Planning Training Centre functioning in association with the S.C.B. Medical College.
