water development through construction of dugwells, bore wells, filter points and shallow tubewells etc. in private sector by the farmers themselves through loan assistance from the banks and subsidy to small and marginal farmers by Government. Only the scheme of higher capacity deep tubewells i.e. public tubewells, is taken up by the Government Departments or Corporations themselves. In the Sixth Plan following physical and financial targets have been fixed :--

## Interpool arrangement for Allotment of Government Accommodation

2407. SHRI R. L. P. VERMA : Will the Minister of WORKS AND HOUSING be pleased to refer to the reply given to Unstarred Question No. 2625. on 26 July, 1982 regarding interpool arrangements for allotment of Government accommodation and state :

(a) the number of applications in which inter-pool adjustment is required, received and pending in those respective departments having their own departmental pools separately during 1981 and 1982;

(b) what efforts have been made by these departments for allotment

of quarters on ad-hoc basis to the wards of retired Government employee of different pools; and

(c) if not, the reasons therefor?

THE MINISTER OF PARLIA-MENTARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH): (a) As the concession of ad-hoc allotment of Government accommodation to the eligible ward on the retirement of parents does not provide for inter pool arrangements no statistical data regarding number of cases involved has been kept.

(b) and (c). The concession of adhoc allotment to the wards of retiring Government servants is based on the recommendations of the National Council (JCM) which has not recommended for inter pool arrangments. However, on the basis of the reference which was received from the Department of Personnel and A. R. the question of providing inter pool adjustments was examined in consultation with the various Ministries and Departments of the Government of India and many of them have not supported the proposal.
