Drinking Water in Indian Villages

- HARIKESH 2411. SHRI BAHADUR: Will the Minister of HOUSING be WORKS AND pleased to state:
- (a) whether it is a fact that only 10 per cent of Indian villages have access to drinking water despite of the expenditure of Rs. 622 crores (Surya' Sept. 1982); and
- (b) whether Government propose to have a programme of hand pumps for every village in the country in view of energy crisis?

THE MINISTER OF PARLIA-MENTARY AFFAIRS AND WORKS AND HOUSING (SHRI BHISHMA NARAIN SINGH) : (a) Out of 5.76 lakh villages as per 1971 census, 2.31 lakh villages have been identified by the State Government as 'problem villages' still to be covered with safe drinking water supply as on 1-4-1980.

(b) Due to limited financial resources and with a view to achieve maximum coverage of identified problem villages it has been impressed on the State Governments to go in for low cost solutions like installation of Hand-pumps whenever feasible.
