(b) The detailed Project Report and cost estimates are yet to be prepared.

- (c) Setting up of the industrial Estate will be yet another step in furthering economic cooperation with Nepal and strengthening our friendly relations.
- (d) and (e). HMG Nepal and Government of India have agreed, in principle, to form a Joint Industrial Committee to further industrial cooperation between the two countries. The detailed modalities including the terms of reference are still to be finalised

The remaining liabilities of Hindustan Tractors Limited covered under Section 5(1) of the Act would be discharged by the Commissioner of payments out of funds provided to him by the Government of India under the Act in the order of priorities as provided under Schedule to the Act. The Commissioner of Payments has been appointed for the purpose. The notification specifying the date by which the claimants may submit their claims to him, will be issued shortly.
