New LPG Connections

1589. SHRI R. P. GAEKWAD: Will the Minister of ENERGY be pleased to state:

- (a) the number of new L. P. Gas connections given during the year 1982 and the connections likely to be made available during the year 1983; and
- (b) the number of consumers of the LPG on the waiting list during the years 1982 and 1983 in the country and also in the State of Gujarat?

THE MINISTER OF STATE IN THE DEPARTMENT OF PETROLEUM IN THE MINISTRY OF ENERGY (SHRI GARGI SHANKAR MISHRA): (a) Total number of LPG conections given during the year 1982 was 12.5 lakhs approximately. The connections planned to be given during 1983 are expected to be in the range of 15 to 16 lakhs.

(b) Waiting lists are maintained on continuous basis and not on year-wise basis. The number of applicants for LPG connections on the waiting list as on 31-12-82 was 42.62 lakhs which includes 4.90 lakhs in Gujarat.
