(b) 448 Instructors. 29 Carpenters and 8,377 Spinners were trained during 1958-59 and 420 Instructors, 86 Carpenters and 14,446 Spinners have been trained during 1959-60 (upto December, 1959) in Madras State. Information about the value of yarn produced during the training period is being collected and will be laid on the Table of the Sabha.

(c) The expenditure incurred on training schemes was Rs. 13:55 lakhs during 1958-59 and Rs. 2:33 lakhs during 1959-60 (upto December 1959). The cost of Charkhas distributed to the spinners amounted to Rs. 10:22 lakhs during 1958-59 and Rs. 11:63 lakhs during 1959-60 (upto December, 1959).

The delay in finalising the index number was owing to non-receipt of price returns and State series of index numbers from the price collecting agencies and the State Authorities.
