construction of such godowns on the understanding that they would extend storage facilities to the neighbouring willages whenever possible.

Written Answers

(e) Both in the interest of State Trading and co-operative marketing of agricultural produce, the co-operatives should be given monopoly for proof foodgrains, wherever gurement state trading in foodgrains is introduoed.

Par-Boiled Rice

- 388. Shri P. C. Borocah: Will the Minister of Food and Agriculture be pleased to state:
- (a) whether it is a fact that parboiled rice is superior to ordinary raw rice in nutritive qualities:
- (b) if so, what measures have been taken to popularise the procees of par-boiling throughout the country:
- (c) what specific steps have taken by Government to implement the new improved methods of parboiling in the rice mills in the country;
- (d) whether they are going to be introduced on a large scale; and
- (e) whether the possibilities of using rubber roller type hullers by rice mills have been examined?

The Deputy Minister of Food and Agriculture (Shri A. M. Thomas): (a) Yes.

- (b) and (c). Apart from objections on sentimental grounds, unpleasant odour often stands in the way of larger consumption of par-boiled rice Improved methods of par-boiling have been developed at the Central Food Technological Research Institute. Mysore, and at the Jadavpur University, Calcutta, by which par-boiled rice free from unpleasant odour and more attractive in appearance can be produced. How the rice millers can be persuaded to produce such parboiled rice and how it can be popularised are now being examined in consultation with the Scientific Advisory Panel of the Food Department.
- (d) Yes, it is the intention to encourage the production of par-boiled rice.

(e) Yes, rubber roller type hullers would produce less brokens, but such hullers are not being made in the country at present. Besides, Sheller type of mills are considered preferable to hullers.

C.D. Block at Khowai (Tripura)

- 289. Shri Dasaratha Deb: Will the Minister of Community Development and Co-operation be pleased to state:
- (a) whether any Advisory Committee has been formed for the Community Development Block at Khowai, Tripura;

- (c) Preliminaries have been completed and the work is expected to be started within a few days.

(d) The work of black-topping of all important roads of Agartala townis expected to be completed within the financial year 1960-61.

Cold Storage Plants
