

(b) whether it is proposed to increase the outlay in view of the need for development schemes and manifold improvement in Delhi and fast expanding population of Delhi; and

(c) if so, the details thereof?

THE MINISTER OF PLANNING (SHRI S. B. CHAVAN): (a) and (b). The total outlay for the Annual Plan of Delhi for 1983-84 has been fixed at Rs. 250 crores keeping in view the need for development schemes and the manifold improvement in Delhi and the fast expanding population of Delhi.

(c) The details of the Annual Plan of Delhi may be found in the Plan Budget document of the Government of India for 1983-84 which has been presented to Parliament on the 28th February 1983.

#### **Distinction in life style of tribals and Scheduled Castes**

1838. SHRI BHEEKHABHAI: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether Government have considered distinct and different types of living, customs, costumes and dialects of tribal people than those of Scheduled Castes;

(b) whether it is a fact that some of them are leading primitive life; and

(c) if so, the steps taken by Government to protect their culture and bring them to the main national stream?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): (a) The Government are aware of the distinct and different types of culture, language and way of living of the tribal people.

(b) Certain tribal groups are more backward and 71 such groups have been identified for special attention for their development.

(c) The policy of the Government is to undertake tribal development programmes for their socio-economic development without interfering in their way of life and to enable them to advance along

the lines of their own genius towards the national mainstream.

#### **Resources gap among States**

1839. SHRIMATI SUSHEELA GOPALAN: Will the Minister of PLANNING be pleased to state the State-wise resources gap and reaction of Government thereto?

THE MINISTER OF PLANNING (SHRI S. B. CHAVAN): Presumably, the question relates to the current year 1982-83. The final position in this regard would become known only after the close of the year. All the State Governments except five expect to end the year without any deficit. In the case of these five, which are listed below, deficits are anticipated as shown against each.

Anticipated deficit at the end of 1982-83.

In these cases, this anticipated deficit has been taken into account in computing the resources for the next year's Annual Plan.

(b) whether it is a fact that the project has been undertaken at a time when the aluminium industry is facing global recession with multi-national giants pulling out of their smelting operations in the third world; and
